Roll Call

Mayor Buckley opened the meeting and City Clerk Kathy Marlock commenced with the roll call. All Board members were present and constituted a quorum for the transacting of City Council business.

Minutes

Mayor Buckley introduced the minutes for April 10, 2018 and asked for a motion to approve the minutes. Alderman Kauffmann made the motion to approve the minutes; this was seconded by Alderman Scherer and the motion carried unanimously.

Discussion/Organizational Chart

Mayor Buckley introduced the discussion of the organizational chart noting that she wanted everyone to be aware of the layout of the employee structure. She also noted that she wanted to clarify operations as they are presently working, today.

Discussion/City Comp Plan

Mayor Buckley introduced the topic of the recent work on the City Comprehensive Plan. She noted that in lieu of hiring a consultant at a cost of tens of thousands of dollars, she encouraged Director Jonathan Greever to work on the Comp Plan and gave him much praise in bringing it this far. She indicated that the City Comp Plan is not yet complete but is closer and that the document serves to identify "what exists" in the City of Shrewsbury and does not constitute a plan that recommends changes for the future. She further stated that since the plan had not been updated for 47 years that this update was greatly needed and will serve the City well.

Mayor Buckley then discussed that larger homes appear to be missing in Shrewsbury; and, she noted that there is no mixed-use zone in the zoning structure of the City of Shrewsbury. Mixed use, she further stated, is currently addressed under Planned Developments in the City insofar as it is addressed at all. She then closed the discussion with the statement that the two areas noted are for the future consideration of the Board and Commission.

Liquor License Approvals

Mayor Buckley then introduced four St. Michael's Church liquor license applications for 2018. These included: a) Church picnic June 4, 2018, b) Soccer Tournament August 8-19, 2018, c) Oktoberfest October 5, 2018 and the d) the Annual Liquor License application. She requested a motion to approve all at once; Alderman Kopff abstained given his association with St. Michael's. Alderman Scherer made the motion to approve; Alderman Gorman seconded the motion; and, the motion carried with five votes in favor.

Purchase: Public Works Department - Chip Seal Bid - West Contracting

Mayor Buckley invited Director Wagner to address the Board by discussing the Chip Seal Bids received. Tony Wagner reviewed the bids received for the Chip Seal work for Summer, 2018. He received bids from West Contracting, Missouri Petroleum, and Gershenson Construction. Director Wagner recommended that the bid from West Contracting be accepted in the amount of \$43,573.00. Alderman Travaglini made the motion to approve; Alderman Kauffmann seconded the motion; and, the motion carried unanimously.

Bill No. 2932 - Short Term Rentals

Second Reading, Consideration for Passage

AN ORDINANCE AMENDING CHAPTER 410 OF THE SHREWSBURY CITY CODE PERTAINING TO SHORT-TERM RENTAL OCCUPANCY IN RESIDENTIAL ZONES.

The Mayor then introduced Bill No. 2932 related to short-term rentals and noted that there would be a second reading, as well as consideration for passage. She then called for discussion. There being no discussion she called for a second reading by title only in accordance with Section 79.130 as

approved by the General Assembly of the State of Missouri, to read the Bill by Title only. Alderman Travaglini made the motion for the second reading by title only, seconded by Alderwoman Gorman. City Attorney Mike Daming conducted the reading. The Mayor then asked for any further discussion. There being no discussion the Mayor called to consider Bill No. 2932 for passage. Alderman Travaglini made the motion for passage, seconded by Alderwoman Gorman. The motion passed unanimously with a roll call vote recorded as follows:
