Roll Call

Mayor Buckley opened the meeting and City Clerk Kathy Marlock commenced with the roll call. Alderman Steingruby was absent, all other board members were present.

Closed Session

The Mayor acknowledged the need for a Closed Session at the beginning of the meeting. She verified with the public the nature of the Closed Session; the Work Session continued immediately following. Alderman Mike Travaglini made the motion for the Closed Session at the beginning of the meeting. Alderman Kauffmann seconded the motion and it passed unanimously.

Approval of Minutes

The Mayor then introduced the minutes for the 8-8-2017 Regular Session of the Board of Alderman and invited discussion. There being no discussion, Alderman Traavaglini made a motion to accept the minutes as presented. Alderman Scherer seconded the motion. The minutes were unanimously approved.

Hear Citizens

The Mayor asked if anyone wished to approach the Board. City of Shrewsbury resident, Sue Nahrstedt, who lives at 5110 Exeter Avenue presented her request for a Handicapped Parking space in front of her home. She explained that she shares a driveway with her neighbor; and that the driveway is often filled since it does not include two lanes for each home. She elaborated upon her hardship of having difficulty walking and having to park several houses away with groceries. Ms. Nahrstedt's request was affirmed and supported by the Mayor and Board of Aldermen.

Approval of the Center at Kenrick Plaza Community Improvement District (CID) Fiscal Year 2017 Budget

The Mayor introduced the CID Fiscal Year 2017 Budget discussion for the Center at Kenrick Plaza. Director Jonathan Greever verified that he and Director Danielle Oettle both sit on the Board of Directors for the Center at Kenrick Community Improvement District. Director Greever also verified that the budget presented represented appropriate costs totaling \$64,500. This represented \$7,500 in administrative costs as well as reimbursement of \$57,000 eligible costs. Alderman Travaglini made a motion to accept the budget; Alderwoman Gorman seconded the motion. The motion passed unanimously.

Ordinance

(Bill No. 2907) Community Development Block Grant (CDBG) Supplemental Agreement-First Reading, Second Reading, Consideration for Passage

Mayor Buckley introduced Bill No. 2907, an ordinance authorizing the Mayor to enter into a supplemental cooperative agreement with St. Louis County, Missouri for the allocation of 2017 Community Development Block Grant Project Funding. She opened the floor for discussion, and there being none, the Mayor called for the First Reading of the motion. The motion was made by Alderman Scherer, seconded by Alderman Travaglini, and unanimously passed in accordance with Section 79.130 as approved by the General Assembly of the State of Missouri, to read the Bill by Title only for the first time. City Attorney Daming conducted the first reading. Mayor Buckley again opened the floor for discussion and a second reading. There being no discussion, Alderman Scherer made a motion that Bill No. 2907 be read by Title Only a second time. Alderman Travaglini seconded the motion. City Attorney Daming conducted the second reading. The Mayor then opened the floor for final discussion. There being no discussion, the Mayor called for a motion for Consideration for Passage. Alderman Scherer moved that Bill No. 2907 be considered for passage; Alderman Travaglini seconded the motion and upon roll call, the following vote was recorded: Alderman Kauffman, "Aye"; Alderman Travaglini, "Aye" Alderwoman Gorman, "Aye"; Alderman Scherer, "Aye"; Alderman Kopff, "Aye".

(Bill No. 2905) Commercial Vehicles Prohibited from Using Certain Streets First Reading

Mayor Buckley introduced Bill No. 2905, an ordinance amending section 383.020: Commercial vehicles prohibited from using certain streets; of chapter 383: regulating the kinds and classes of traffic on certain highways; of title III; traffic code; of the City of Shrewsbury, Missouri Code, providing for the repeal of all conflicting ordinances; and providing for the effective date of this ordinance. She opened the floor for discussion, and there being none, the Mayor called for the First Reading of the motion. The motion was made by Alderman Kauffmann, seconded by Alderman Scherer, and unanimously passed in accordance with Section 79.130 as approved by the General Assembly of the State of Missouri, to read the Bill by Title only for the first time. City Attorney Daming conducted the first reading.

The Mayor verified that the Ward Meetings were to be held immediately following the Work Session and were scheduled in the following second floor rooms: Ward I, Room 3, Second Floor, Ward II, Room 4, Second Floor, Ward III, Room 5, Second Floor. She further commented that she hopes to have Ward Meetings coordinated twice per year.
